Office Order

1. Essential services of the institute like; farm-based research activities, Security service and Estate unit for sanitizations & cleaning will be carried out under supervision of Chairman, RRT with compliance of preventive norms of COVID-19 up to **09/05/2021.**
2. All PI's/In-charge of unit/section may carry out only essential activities with bare minimum staff as per their need.
3. Head of finance may carry out only essential financial activities like; disbursement of salaries, release of payment of time bound & essentially required vouchers and bills, if any with bare minimum staff as per their need.
4. During this period, all other officials and staffs are required to work from home and shall be available over telephone & electronic means of communications at working hours and are not allowed to leave the HQ. They will also liable to attend the office in view of urgency, if any decided/called by the concerned controlling authority.
5. The general & preventive directive issued by MHA, DoPT, MoA & FW & Government of Haryana from time to time, should be strictly followed by all IIWBR officials/staffs,
